

#### 2023 / 2024 SAILING SEASON NOTICE OF RACE & SAILING INSTRUCTIONS FOR CLUB RACING

#### RULES

The races will be governed by the:

Rules as defined in the Racing Rules of Sailing (RRS) 2017 - 20 and 2021 - 2024 Equipment Rules of Sailing (ERS) 2017 - 20 and 2021 - 2024 as well as the relevant Class Rules.

This combined Notice of Race and Sailing Instructions and any amendments thereto.

#### **ELIGIBILITY AND ENTRY**

The racing is open to all sailing boats. Boats may enter via a standing entry or Boats may enter by completing an entry form and paying the required entry fee at the HMYC Committee Room, up to 1 hour prior to the start of the race.

#### **CHANGE OF CREW**

The skipper or person designated to be in charge of a boat (refer to RRS 46) may not be changed during a series. Other crew members may be changed between races of a series.

#### FEES

Required entry fees are as follows: Class and Club Championships: All Other Series or Club Racing: Mini Regattas: Special Events:

R35-00 per day. R35.00 per day. R35-00 per day or R70-00 for 2 days. As per Notice of Race.

#### NOTICES TO COMPETITORS

Notices to competitors will be posted on the blackboard located on the Clubhouse veranda.

#### **CHANGES TO SAILING INSTRUCTIONS**

Any change to the sailing instructions will be posted at least 1 hour before the start of the race in which it will take effect.

#### SIGNALS MADE ASHORE

Signals made ashore will be displayed on the mast adjacent to the club house. When Flag 'AP' is displayed ashore, "1 minute" is replaced with "not less than 30 minutes" in the race signal AP.

When Flag Y is displayed ashore, RRS 40 applies at all times when afloat. Personal flotation devices shall be worn at all times while afloat.

# SCHEDULE OF RACES

The schedule of races is as displayed in the calendar on the HMYC website at: <u>www.hmyc.org.za</u>. The scheduled number of RACES PER RACING DAY is as indicated below:

Series races per day Class Championships x 3 Short Course Championships x 5 Club Mini Regattas x 5 All Other Series or Races x 2

## FLEET FLAG

Flag T will be used as the Fleet Flag.

## **RACING AREA**

Racing will take place on Midmar Dam.

# THE COURSE

The course to be sailed will be displayed on the blackboard on the Clubhouse veranda.

## MARKS

Marks to be used will be indicated on the blackboard on the Clubhouse veranda.

# THE START

Races will be started by using RRS 26 with the Warning Signal given 5 minutes before the starting signal.

The starting line will be between the start mark and a staff displaying an orange flag on the committee boat.

A boat starting later than 5 minutes after her starting signal will be scored Did Not Start without a hearing.

Alternatively the starting line will be between the orange flag displayed at the end of the jetty and the prescribed anchored keel boat.

## THE FINISH

The finishing line will be between the finish mark and a staff displaying an blue flag.

## TIME LIMITS

Boats failing to finish within 20 minutes after the first boat sails the course and finishes will be scored Did Not Finish without a hearing. This changes RRS 35, A4 and A5.

## PENALTY SYSTEM

Rule 44.1 is changed so that the Two-Turns Penalty is replaced by a One-Turn Penalty.

# SAFETY

Yachts shall comply with the National Small Vessel Safety Regulations, as well as their class buoyancy and safety requirements.

Youth category sailors shall wear a personal buoyancy aid at all times while afloat in a yacht. This includes all persons 18 years and younger.

Wet or dry suits do not constitute a personal buoyancy aid.

## RADIO COMMUNICATION

Except in an emergency a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

# PROTESTS AND REQUESTS FOR REDRESS

- Protests shall be written on forms available from the Race Office. Protests and requests for redress shall be delivered there within the appropriate time limit.
- The protest time limit is 60 minutes after the last boat has finished the last race of the day.
- Notices will be posted within 30 minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the HMYC clubhouse.
- Notices of protest by the Race Committee or Protest Committee will be posted to inform boats under RRS 61.1(b).

On the last day of a mini-regatta a request for reopening a hearing shall be delivered:

- within the protest time limit if the requesting party was informed of the decision on the previous day;
- no later than 30 minutes after the requesting party was informed of the decision on that day. (This changes RRS 66.)
- On the last day of a mini-regatta a request for redress based on a Protest Committee decision shall be delivered no later than 30 minutes after the decision was posted. (This changes RRS 62.2.)

# SCORING

When fewer than 3 races have been completed, a boat's series score will be the total of her race scores.

When 3 or more races have been sailed, a boat's series score will be the total of her race scores, excluding her following number of worst scores:

No. of Races & Discards

3 to 5 = 1 6 to 8 = 2 9 to 11 = 3 12 to 14 = 4 15 to 17 = 5 18 to 20 = 6 21 to 23 = 724 or more = 8

Boat handicaps will be the HMYC equivalent of the Portsmouth Ratings. Skipper handicaps will be at the discretion of the Race Committee

#### Series or Race & handicap system

Class Championships ,Qualifying classes & Open class = Level rating, Boat handicap only Class Handicap, Qualifying classes & Open class = Skipper handicap only, Boat and skipper handicap HMYC Short Course Championships = Boat handicap only Club Mini Regattas = Boat handicap only All Other series or races = Boat and skipper handicap

## CLASS CHAMPIONSHIP AND CLASS HANDICAP REQUIREMENTS

A minimum of four finishers in at least five races is required for a Class to qualify for Class Championships and Class Handicap Results.

## PRIZES

Trophies and prizes will be presented at the HMYC Annual Prize-giving. These will be at the discretion of the Race Committee.

## DISCLAIMER OF LIABILITY

Competitors participate in the club races entirely at their own risk. See RRS 4, Decision to Race. Neither the Organizing Authority nor its officials or other persons associated with the organization of the event will accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### INSURANCE

Each participating boat is encouraged to carry sufficient valid third-party liability insurance to cover any liability arising during the event.
